**3.0 EXAMINATION FEE:** Examination fee is to be paid through ONLINE MODE and Service Charge as applicable will be borne by the candidate. Candidates to note that RRC/NR is not responsible for incomplete or pending online examination fee transaction for whatever reason. In such case candidate need to proceed with fresh/new transaction of payment of examination fee.

(i) For all candidates except those mentioned in sub-para (ii) below: Rs. 500/- (Rupees Five Hundred) only through Online Payment in favour of RRC/NR. The examination fee of Rs. 400/- will be refunded after deducting bank charges to candidate who actually appeared in the written examination.

(ii) For candidates belonging to SC/ST, Women, Minorities, PwBD, ExSM, Transgender and Economically Backward Classes: Rs. 250/- (Rupees Two Hundred Fifty) only. Examination Fee will be refunded after deducting bank charges to these Categories of Candidate only when they actually appear in the Written Examination.

(iii) Candidate to note that in case of refund of Examination Fee it will be transferred back to the source from where it is received in RRC Account.

**NOTE 1:-** 'Minority' means Muslims, Christians, Buddhists, Zoroastrians (Parsis) & Sikhs. Economically Backward Classes will mean those candidates whose family income is less than Rs. 50,000/- per annum.

The following officials are authorized to issue income certificate for the purpose of identifying Economically Backward Classes :

- District Magistrate or any other Revenue Officer up to the level of Tehsildar.
  - Sitting MP of Lok Sabha for persons of their own constituency.
  - BPL Card or any other certificate issued by Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
  - Union Minister may also recommend for any persons from anywhere in the country.
  - Sitting MP of Rajya Sabha for persons of the District in which the MP normally resides.
- The income certificate issued by the authorities mentioned above must be as per format given as Annexure on RRC website. This will have to be issued on the letterhead of the issuing authority.

**4.0 Scheme for recruitment:** The recruitment process shall consist of the Written Examination followed by Document Verification.

**5.0 Medical Examination:** Candidates recommended for appointment will have to pass the requisite medical fitness standards in **Cey-One category** prescribed for the post.

**6.0 Period of Probation:** NA.

**7.0 Period of Training:** The selected candidate will be required to undergo training as per extent rules.

**8.0 Details of Agreement/Security Deposit/Bond to be signed:** NA.

**9.0 Place of Posting:** Selected candidates will be posted in Parliament House- Catering Unit, Commercial Department, Northern Railway, New Delhi

**10.0 General Instructions:**

- Merely Registering/filling up online application on RRC website does not entitle the Cont...

- candidate being eligible for recruitment process. All the recruitments against Open Advertisement quota shall be at the minimum of scale of pay in the Pay Matrix.
- (ii) Railway Administration reserves the rights to recruit eligible candidates at any place. Candidates are also advised not to bring any valuable/costly items to the examination hall as safe keeping of these items can not be assured. Administration will not be responsible for any loss in this regard.
- (iii) The decision of NR administration on all matters relating to eligibility, place, date, mode of selection, acceptance or rejection, recommendation of post, place of posting, grade etc. shall be final and binding on the candidates.
- (iv) Candidates already employed in Govt. Service should submit Online Application with NOC from the Employer, without which application shall be summarily rejected at any stage.
- (v) The candidature of the applicants shall be liable to be rejected at any stage of recruitment in case of concealment of any fact, which is in contravention to the above laid down conditions. The decision of the Railway Administration shall be final and binding on the candidates.
- (vi) No TA/DA/Accommodation will be given for appearing in the recruitment process. However in case of SC/ST candidates who have uploaded their proper community certificate will be given free travel authority (2nd class) with E Admit Card and such candidates will be allowed to use this authority to travel on production of self attested copy of E-Call letter and SC/ST certificate. During the journey these candidate should carry E-Admit Card with original SC/ST certificate and original proof of identity failing which they will be treated as without ticket and charged accordingly.
- (viii) Shortlisted candidates shall bring all relevant documents including uploaded with ONLINE Application Form in Original along with one set of **self attested** photo copies (Date of Birth Matriculation or Equivalent Certificate, Educational Qualification, Technical Qualification, Caste Certificate, EWS Certificate (the income & assets of the family would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs), PH Certificate, Ex-SM Certificate/Discharge Book, CCAA from Railway Establishment, NOC if working etc. on the day of document verification without which they will not be allowed to appear in the process of recruitment. Certificates in languages other than English or Hindi should be accompanied by a self attested translation in English/Hindi.
- (ix) Candidate should be in readiness to appear for the written test at short notice after the last date for submission is over.
- (x) Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions.
- (xi) The service of the candidate shall be terminated, if the information and documents furnished by him/her for recruitment are found incorrect/ fake at any stage.
- (xii) No candidate should attempt impersonation or take the help of any impersonator at any stage of the recruitment process. Such candidates will be debarred for life from appearing in all RRB/RRC examinations or any appointment in Railways. In addition, legal action shall be taken against the candidate.
- (xiii) Any material suppression of facts or submitting of forged certificates/caste certificate by a candidate for securing eligibility and/or obtaining privileges, including fee exemption for appearing in the recruitment shall lead to rejection of his/her candidature for the particular recruitment for which he/she has applied. Further, he/she will also be debarred from all examinations conducted by all RRB/RRC over the country.
- (xiv) Candidates who have been debarred for life from all RRB/RRC examinations or candidates who have been debarred for a specified period which is not yet completed need not apply in response to this employment notice. Their candidature will be rejected during any stage of recruitment as and when detected.
- (xv) Recruitment will be dealt as per policy read with modifications/ amendments issued by the Railway Board from time to time on the subject.
- (xvi) Any subsequent changes in the terms and conditions of this Employment Notice as per extant rules shall be applicable. RRC reserves the right to consider/incorporate any subsequent changes/ modification/additions/cancellation in the terms & conditions to recruitment under this Employment Notice as and when applicable.
- (xvii) The vacancies as mentioned above in both service side and cooking side may decrease or increase as per administration requirement.
- (xviii) RRC reserves the right to reject the candidature of any applicant at any stage of the process of recruitment, if any irregularity/ deficiency is noticed in the application.
- (xix) For any Legal Dispute, the Jurisdiction will be at New Delhi only.
- (xx) In the event of any dispute about interpretation or any mistake, the English version will be treated as final.
- (xxi) Canvassing in any form, misbehavior or misconduct will lead to summary rejection and cancellation of candidature and no correspondence will be entertained in this matter.

(xxii) **Candidates to note that all relevant certificates showing the minimum eligibility of the candidate to appear in the written examination i.e Educational/ Technical qualification and Caste Certificates etc. are to be uploaded with online application form.** Original Certificates are required at the time of subsequent stage i.e Document Verification failing which applicant shall not be allowed to participate in the recruitment process further.

**11.0 Invalid Application:** Any of the following deficiencies/discrepancies found in the online application form and documents submitted by the applicant will render the application invalid / rejected:-

- Application not in prescribed format and incomplete or illegible application.
- Applications without photograph, LTI impression, unsigned application and/or Signature in capital or different signature at different places during the recruitment process.
- Applications without Examination fee or less fee.
- Applications without proof of date of birth, educational qualifications, Technical Qualification & Caste Certificate etc, as applicable.
- Over age or under age, date of birth not filled or wrongly filled,
- Self-attested photocopies of requisite certificates not uploaded.
- Not having requisite educational qualification & Technical qualification at the time of applying.
- Application which are filed in a language other than English or Hindi.
- Any other irregularities which are considered invalid by RRC.

**12.0 MISCELLANEOUS:**

- Railway Administration will not be responsible for any inadvertent error in the advertisement RRC website would be primary and main source of contact with the candidates for various information during the process. The status of the candidates will not be intimated by post.
